About speaker –Ms Vignesvary Alahakone

Ms. Vicky Alahakone is a graduate from the University of Singapore and specializes in Family Law. She has been in active legal practice over the past forty (40) years and in the course of her career has presented several papers on various aspects of family law both locally and overseas.

She presented a paper on Domestic Violence in Malaysia at the 6th World Congress on Family Law and Children's Rights held in Sydney, Australia. She has presented papers at the Malaysian Bar National Conference in Kuala Lumpur and also at the International Law Conference organized by Lawasia. She is a regular speaker with BFM on issues related to family law and gives talks to young lawyers with the Legal Aid Centre, the Kuala Lumpur and Selangor Bar. She is currently a member of the Family Law Committee with the Malaysian Bar.

She works closely with several NGOs including PS The Children, an NGO set up to protect and save sexually abused children. She assisted them with the preparation of workbooks to be distributed in schools to bring awareness to school children on sexual abuse and exploitation. She was the former President of the Association of Women Lawyers (AWL) and the former Vice President of the Women's Aid Organisation (WAO). She has worked closely with victims of domestic violence and assisted them in court. She also works with Pemalik an NGO set up to highlight the adverse effects of parental alienation on children caught up in custody disputes and divorce.

Her vision is to see an eradication of domestic violence in Malaysia. Her mission is to assist relevant bodies to highlight, improve and implement proper systems to protect victims from further abuse by the very system that is meant to protect them.
