Talk Outline:-

The most fought over area in matrimonial proceedings is usually over the children. What do guardianship, custody, care and control of children mean? How much access is reasonable for the parent not having custody? Who determines the religion and education of children? Should judges interview children? How should matters proceed in court?

What happens when a parent abducts his own child? Is there a way to prevent this?

These and other matters will be the subject of discussion in this talk.

About the speaker Honey Tan Lay Ean has an LLB from the University of Buckingham, and an LLM from Warwick University. She is the Co-Deputy Chairperson of the Family Law Committee of the Malaysian Bar.

Honey's main area of practice is in the field of high conflict matrimonial law. She is also engaged in public interest litigation, primarily in the areas of equality and non-discrimination.

About the speaker Matt Wong Chong Ee has an LLB from the University of London. He serves on the Family Law Committee of the Malaysian Bar, and the Civil Practice and Court Liaison Committee of the Kuala Lumpur Bar Committee.
