Dr. Ramalinggam Rajamanickam is a Senior Lecturer in the Faculty of Law, Universiti Kebangsaan Malaysia (UKM). He is holding administration post as the Assistant Dean of Quality and Strategy, Faculty of Law, Universiti Kebangsaan Malaysia (UKM). He is a product of UKM as he has obtained Bachelor of Laws, Master of Laws and Doctor of Philosophy in Law from UKM. In addition, he also has two professional diplomas in translation, one in Legal Module and another in Communication Module. Both diplomas were awarded by the Malaysian Translators Association in collaboration with Dewan Bahasa dan Pustaka (DBP). His area of expertise includes Forensic Law, Law of Evidence, Criminal Justice System, Malay Language and Translation. He has a vision of enriching the body of knowledge in the legal field, particularly relating to evidence and forensic law.
