He has an illustrious career presented papers on many occasions, was a key speaker at many conferences and presented the newly-enacted Competition Act 2010 to the Japan Fair Trade Commission and Japan International Business Association, among others. As a lecturer he introduced a new Competition Law course based on the Competition Act 2010 at the Faculty of Law, University of Malaya. He has published a number of articles in international journals. He was called as Barrister-at-Law to The Honourable Society of Lincoln's Inn in 1996.
