The standard form of building contract published by the Persatuan Akitek Malaysia (PAM) is probably the most widely used contractual form for construction works in the private sector. The latest version has just been issued in 2018. This is the 4th version since its introduction in 1969. This talk takes a journey through the form to discuss the important provisions and their implications.

He holds a PhD in construction law from the University of Malaya. He obtained both his LLB Hons and LLM degrees from the University of London.
