## Outline of Topic

*The new norm is now spanning beyond protective measures we see in day-to-day life, into the world of commerce. Businesses are being seen pivoting from the use of analogue information towards digital data, amongst other things. Accordingly, there is the unavoidable need to understand the implications of digitisation, on contractual rights and obligations in the present day workplace. This webinar will highlight the differences between physical and digitised contracts, digital authentication, data security, and related issues. It will in particular, discuss some of the legal implications of digitisation and its effect on contractual requirements, including enforceability, offer and acceptance and authentication, and issues arising from the digitalisation of businesses, such as cloud computing.*
